Stop Raids

(Explanation)

- Stop raids, also known as liquidity hunting or stop hunting, are strategies used by institutional traders to manipulate the market to trigger stop-loss orders of retail traders. This is done by creating movements in the market that go just above or below key areas where many traders have placed their stop-loss orders. When these orders are triggered, the price reverses, and institutional traders can enter or exit positions at more favorable prices.

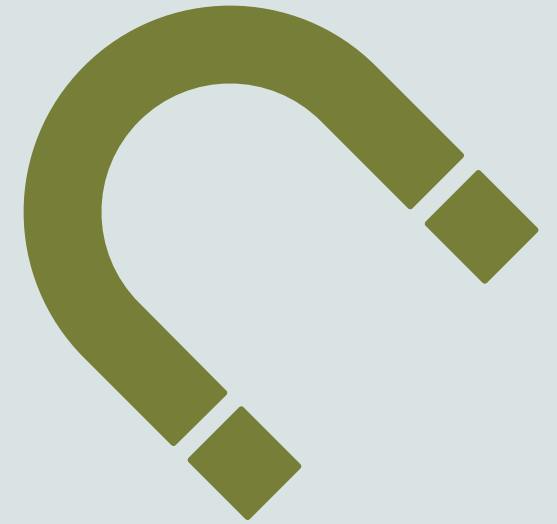

Draw on Liquidity or DOL

(Explanation)

Understand DOL like a magnet which pull or attract price to itself and why it does so. As I explained in the stop raids concepts that there are stop orders resting above or below key points which price would like to raid. Think of this like the stop raid. The difference is that the move has not happened yet. Price is attracted or pulled towards an **IMBALANCE** or **KEY LIQUIDITY** areas which will help us to determine our bias. In this, we will look for a DOL on 15M or 1H Time frame.





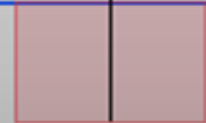

Fair Value Gap or FVG's

(Explanation)

- FVG's refer to areas on price charts where rapid price movement has occurred, leaving a "gap" without much trading in between. These gaps often act as magnets for future price action, with the expectation that prices will eventually return to these zones to "fill" the gap.

Optimal Trade Entry

- OTE zones are determined by looking for areas where the market is likely to provide the best risk-to-reward ratio for entering a trade. These areas often occur after a market retracement or pullback within a larger trend. The underlying idea is that the market will often retrace a portion of its recent movement before continuing in the direction of the overall trend, offering a favorable entry point.

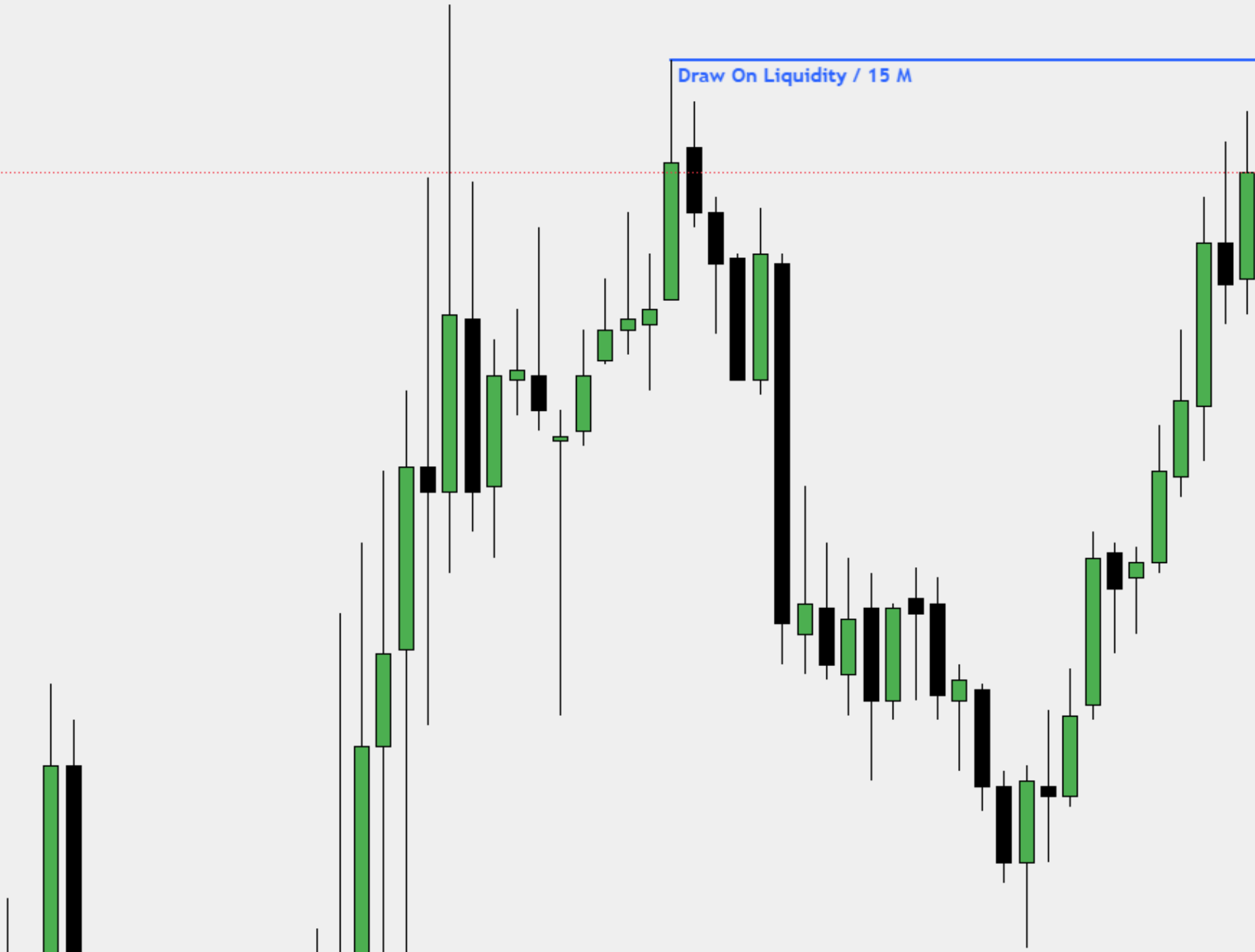
OTE Zone

Stop Loss and Take Profit

- Place your protective stop loss on swing high where OTE is drawn if bearish and vice versa. (1 OTE Level).
- Take profits at the swing low of marked OTE if bearish and vice versa (-0.5OTE Level).

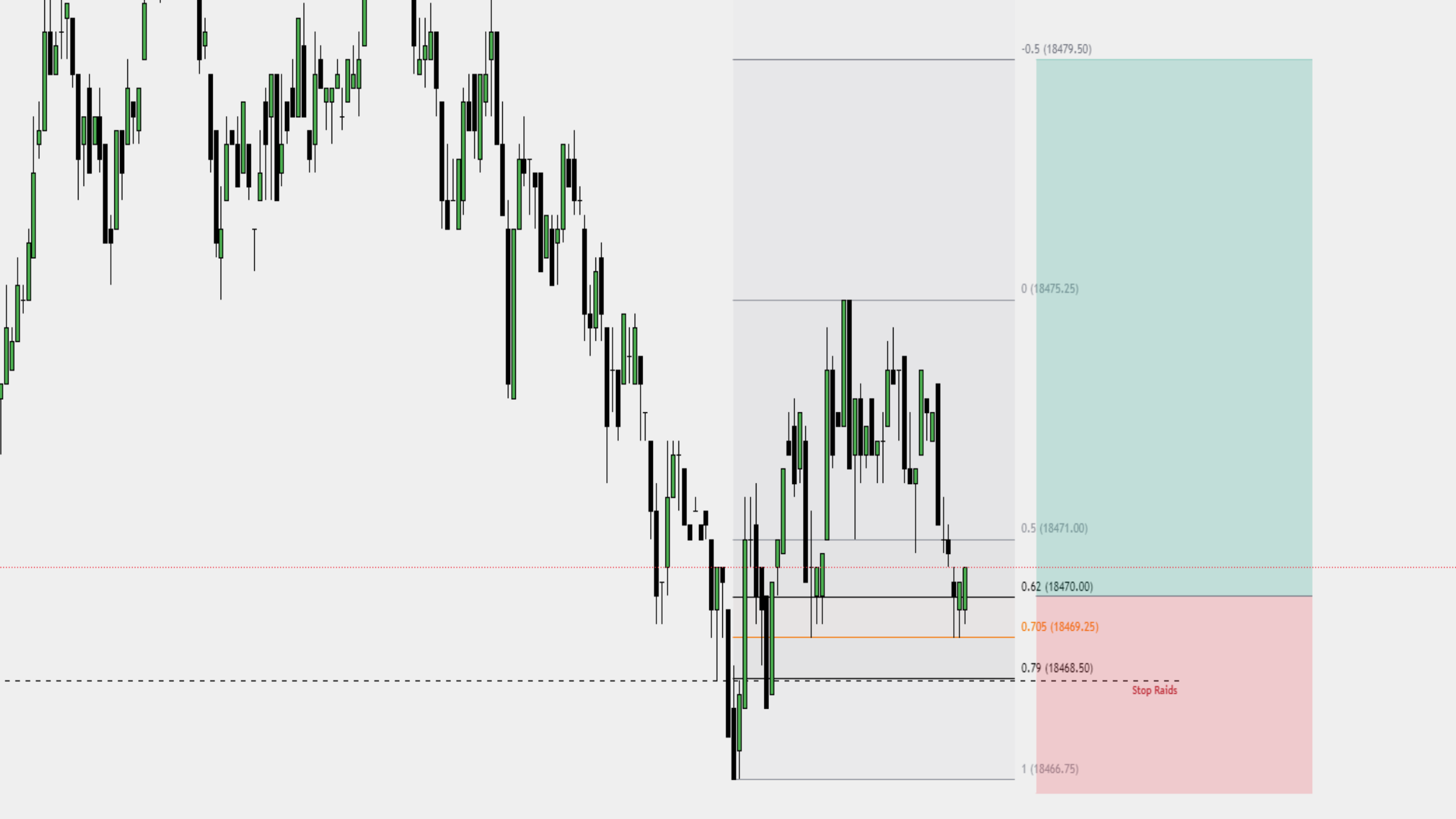
